for you, who intend to work or study in the city of Nitra, we have prepared a brief information booklet. In the following chapters we will briefly explain how to proceed if ...

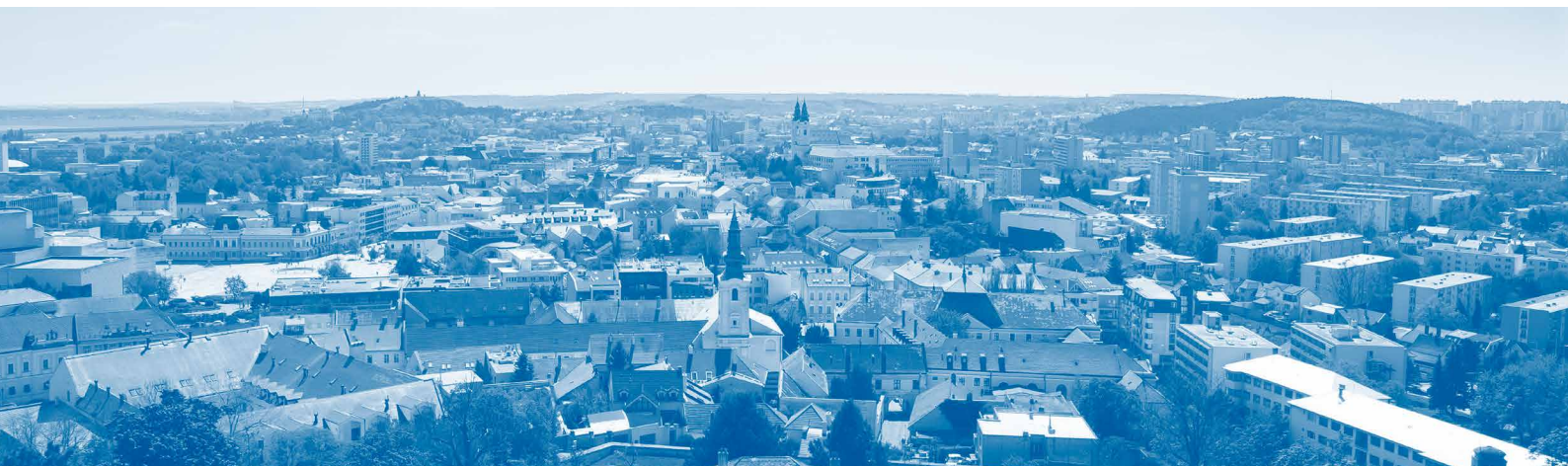
- ✓ you moved to Slovakia and want to live in Nitra,

This booklet was prepared by team members actively participating in the project „COMIN – Establishment of a Community Center for Work and Knowledge Mobility in Nitra“, which main goal is to create conditions for the social inclusion of foreigners in our city. It is the first community project of social inclusion of foreigners in the Slovak Republic. COMIN project was established by a local government decision and it is implemented within intersectoral cooperation of several entities - the City of Nitra, Nitra NGOs, employers and government agencies operating in our city.

CITY OF NITRA

The city of Nitra is currently the fifth largest city in Slovakia. It is located in Nitra region, northeast of Bratislava. The dominant of Nitra is the Nitra Castle. Through Nitra flows the river of the same name – Nitra. The city of Nitra is known for its rich history, as an agricultural centre and also as a city of youth.

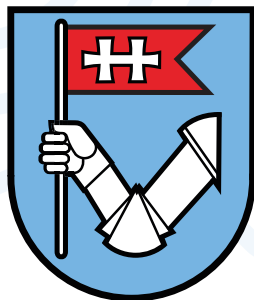
Nitra is divided into 7 city districts:

1. Dolné Krškany + Horné Krškany,
2. Staré mesto,
3. Čermáň,
4. Klokočina,
5. Diely + Kynek + Mlynárce + Párovské Háje,
6. Dražovce + Zobor,
7. Chrenová + Janíkovce.

More than 5,000 foreigners holding a permanent or temporary residence permits live in Nitra. They are mainly from Serbia, Ukraine, Italy, Romania, Bulgaria and the Czech Republic.

Everyone who lives in Nitra and has a temporary or permanent residence, including foreigners, has the right to participate in the self-government of the city.

He/she can participate in local government meetings, address proposals or petitions to the mayor, the city council and local government advisory bodies. Obligations include payment of **local taxes and fees**, e.g. real estate tax, dog tax, tax on the use of public spaces, accommodation tax, local development fees and fees for municipal waste and small construction waste. Residents of the city holding a permanent residence, including foreigners, have the voting rights to the self-governing bodies of the city, they can elect the mayor and the city council, and have the right to be elected and the right to vote in a local referendum.



There is a variety of services related to different areas of life which are provided by city to its inhabitants. City has obligation to **inform its inhabitants**, it issues **permits** (e.g. permits for special operating hours, permits for sales at the market place, permits for the implementation of a business plan in the city, reservation of a parking space, issuance of a parking card, issuance of a voting card, issuance of a fishing license), provides **social care and social service**, issues statements and handles complaints and petitions.

The inhabitants of the city have **notification obligations** towards the city, concerning e.g. cultural events, holding auctions, changes in opening hours for businesses, etc.

HOW TO PROCEED IF ... YOU MOVED TO SLOVAKIA AND WANT TO LIVE IN NITRA

If you are a foreigner and you moved to Nitra from another place in Slovakia or directly from abroad, you are obliged to report your place of residence to the [Foreign Police Department in Nitra](#).

The conditions of entry and residence of foreign nationals in Slovakia depend on whether a foreigner is a national of an EU Member State, the EEC, or Switzerland (hereinafter referred to as the EU), or whether he/she is a so called third-country national.

Nationals of EU member states can enter and stay in Slovakia without further conditions for a period of three months beginning on a date of entry. If they want to stay in Slovakia for a period longer than three months, they are obliged to apply for registration of residence at the Foreign Police Department. A similar condition applies to family members of EU nationals.

Third-country nationals (all foreigners who are not nationals of any EU Member State) may enter and stay in Slovakia for a short period (up to 90 days) based on a [visa](#) or a [visa-free regime](#).

The Slovak Republic can issue two types of visas: type C visa, so-called Schengen visa and type D visa, so-called national visa. A foreigner must apply for a visa at the Slovak embassy abroad. The list of embassies is available on the website of the [Ministry of Foreign and European Affairs of the Slovak Republic](#).

If a third-country national wants to stay in Slovakia for more than 90 days, he/she must hold a temporary or a permanent residence permit. An application for a residence permit must be submitted by a foreigner at the embassy of the Slovak Republic abroad or, in the situation stipulated in the Act on the Residence of Foreigners, at the relevant department of the Foreign Police in Slovakia. In order to submit an application to the Foreign Police Department and for other submissions it is recommended to use the [booking system](#) of the Foreign police.

Temporary residence can be granted for a specific period of time and for one specific purpose. It can be granted for the purpose of business, employment, study, seasonal work, special activities (teaching, sports, artistic, volunteering activities, etc.), research and development, family reunification, performance of duties by civilian components of the armed forces, to a person holding a status of Slovak living abroad or to a person who has been granted long-term residence in another EU Member State or as a Blue Card.

Permanent residence can be granted for 5 years or for an unlimited period. It is not granted for a specific purpose, meaning that foreigner can perform different activities at the same time, e.g. work, do business, study, etc. There are three types of permanent residence: permanent residence for 5 years, permanent residence for an unlimited period of time and long-term residence.

Depending on the type of granted residence permit, you can either carry out one specific economic activity to which your residence permit is linked, or in the case of some types of permits, you can carry out any activity without restrictions. Before you start working or doing business, we always recommend that you find out if you have the necessary permissions to carry out this specific activity. If you carry out the activity without the necessary authorizations or permissions, you along with your employer, are taking a risk of legal consequences.

In the city of Nitra you can get free comprehensive social and legal counselling regarding your residence at one place: it is provided by the First Contact Point, which is located at the Municipal Office in Nitra in the Client Center, Štefánikova trieda 60, Nitra. It provides foreigners with face to face counselling, consultations by telephone and by email.

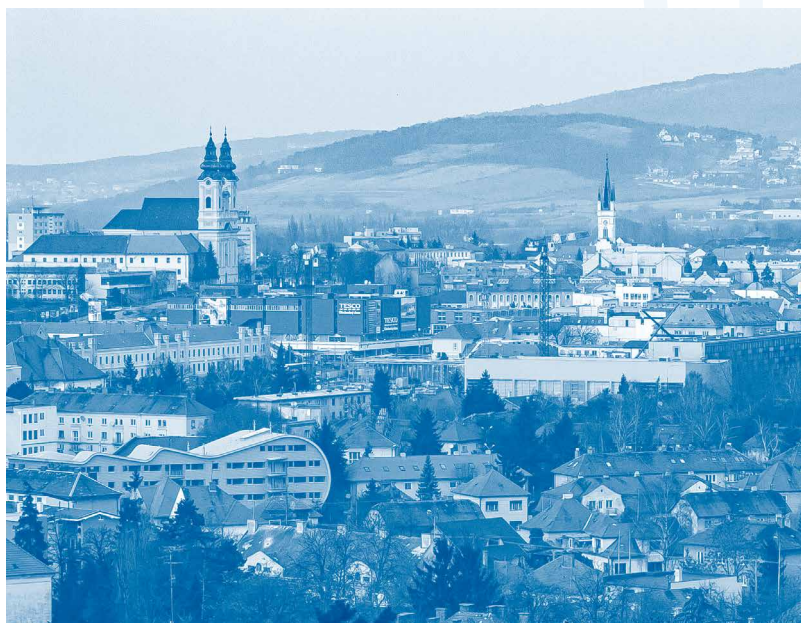

HOW TO PROCEED IF ... YOU WANT TO WORK / DO BUSINESS IN NITRA

In most cases, if you want to work in Slovakia, you or your future employer must contact the [Office of Labour, Social Affairs and Family in Nitra](#) in order to get a work permit or so-called single permit. The right of foreigners to be employed depends on the type of granted residence permit and on the other conditions related to the protection of the labour market in Slovakia.

Every EU national has unrestricted access to the labour market and therefore does not need any work or other permit to be employed. The employer always has an obligation within 7 working days since commencement of the employment of an EU national to send an [information card](#) to the Office of Labour, Social Affairs and Family.

A third-country national may be employed only if:

- ✓ holds an EU Blue Card
- ✓ he has been granted a temporary residence for the purpose of employment after confirming the possibility of a vacancy being filled by a foreigner,
- ✓ he has been granted a work permit and a temporary residence for the purpose of employment,
- ✓ he has been granted a work permit and a temporary residence for the purpose of family reunion,
- ✓ has been granted a work permit and a temporary residence permit as a third-country national who holds the status of a long-term resident in other EU Member State, or
- ✓ falls under the exception defined by law which does not require confirmation of the possibility of filling a vacancy or a work permit.



Information on the employment of third-country nationals, on the issuance of confirmations on the possibility of filling a vacancy by foreigners and on work permits can be found on the website of the [Office of Labour, Social Affairs and Family](#).

If you would like to do business, it is necessary to contact the [Trade License Department of the District Office in Nitra](#). The right to do business depends on the type of granted residence permit. A third-country national who has been granted a temporary residence permit for a purpose of business, a temporary residence permit for the purpose of study, a temporary residence permit for the purpose of family reunion, a temporary residence permit for holders of the status of Slovak living abroad, a temporary residence permit with a recognized long-term residence in another EU Member State or any type of permanent residence can do business in Slovakia. A EU national can also do business without any restrictions. If a foreigner has not been granted any type of residence and he/she wants to do business in Slovakia, he/she can apply for a temporary residence for the purpose of business.

HOW TO PROCEED IF ... YOU LIVE IN NITRA AND WANT TO GET A HEALTH CARE

Every foreigner holding a residence permit/registered in Slovakia is obliged to have a health insurance. Health insurance can be public or commercial (private). If you are employed or self-employed, you become part of the **public health insurance system**. If you are an employee, your employer deducts public health insurance payments from your salary according the rules which are applicable for Slovak nationals. If you are self-employed, you must pay insurance directly to the health insurance company under the same conditions applicable to Slovak nationals.

Foreigners who cannot participate in the public health insurance must take out individual commercial (private) health insurance. The insured foreigner is entitled to health care based on the conditions stipulated in the insurance contract.

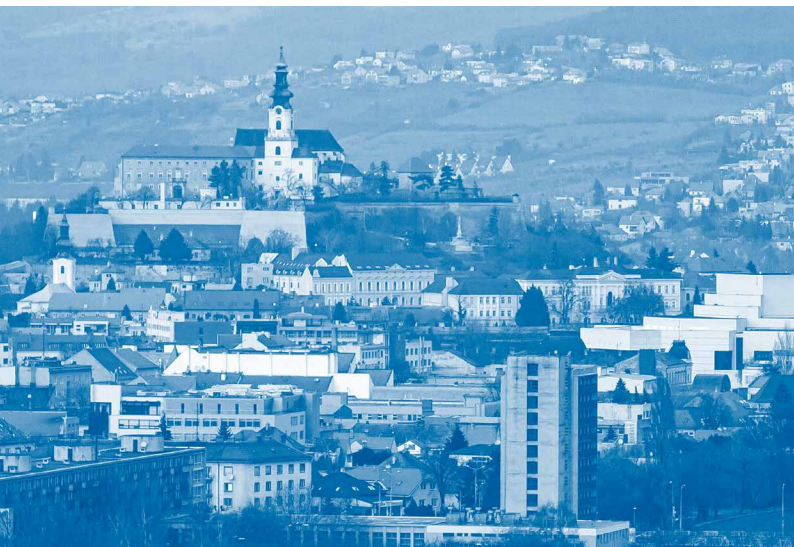

By paying your health insurance, you are entitled to health care under the same conditions as Slovak nationals. Healthcare is provided by registered providers in outpatient clinics or hospitals.

Common health problems are addressed by a GP. Every patient, including a foreigner, has the right to free choose of doctor. If a patient does not have a specific health care provider, he can register with a doctor according to the health district. HOW TO PROCEED IF ... YOU LIVE IN NITRA AND NEED HELP IN A DIFFICULT SOCIAL SITUATION



In general, the same rules and conditions of social security apply to foreigners as you as to Slovak nationals. The social security system is defined as a set of institutions and measures aimed at mitigating the consequences of adverse life situations. In Slovakia, the social security system consists of three pillars: social insurance, state social support and social assistance.



If you are an employee, social insurance is paid by your employer to the social insurance company every month. If you are self-employed, you will pay social insurance to the social insurance company by yourself. Basic information on social insurance and the amount of contributions, as well as the right to social benefits, can be found on the website of the Ministry of Labour, Social Affairs and Family of the Slovak Republic <https://www.employment.gov.sk>.



In case you find yourself in a situation in which you will need social support and assistance services (retirement age, severe disability, placement of a child in a crèche, etc.) or you find yourself in a crisis situation (domestic violence, loss of accommodation, drug addiction, social exclusion, etc.), you can use a wide range of social services and counselling provided by professional departments of the city of Nitra. 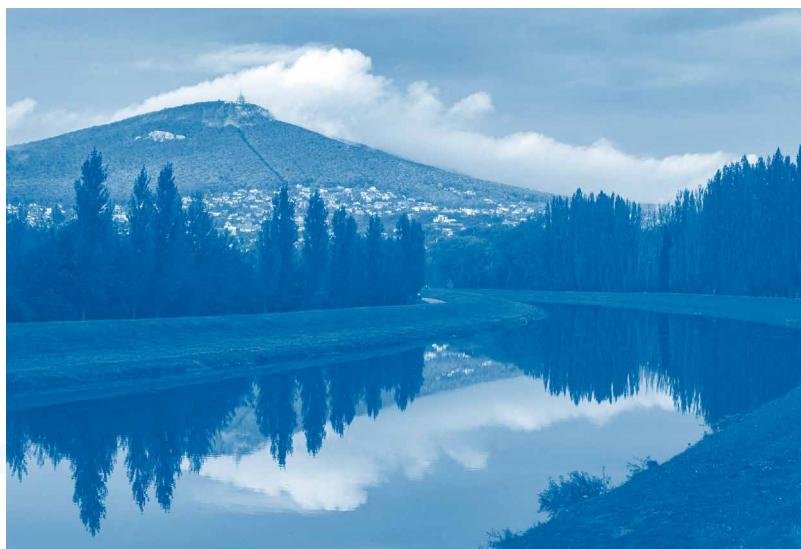

HOW TO PROCEED IF ... YOU LIVE IN NITRA AND YOU MUST ARRANGE A SCHOOL EDUCATION FOR YOUR CHILD OR YOU WANT TO STUDY IN NITRA

The school system in the Slovak Republic consists of the following levels:

- ✔ Kindergartens (3-6 years) - pre-primary education
- ✔ Primary schools (6-15 years) - primary education
- ✔ High schools (15-19 years) - secondary education
- ✔ Colleges, universities (from 19 years) - tertiary education

Pre-primary education



is provided in kindergartens. Children can attend kindergartens from the age of three. The city of Nitra has **27 kindergartens**. Currently pre-primary education facilities are not compulsory. However, from 2021, pre-primary education will be compulsory for all children from the age of 5.

Primary school education

is offered by primary schools. There are **18 state run primary schools**, 3 private schools and 4 church run schools in the city of Nitra. Ten years of compulsory school attendance apply in Slovakia for children from the age of 6 till 16. Enrolment to primary schools usually takes place from 1st till 30th of April. It is



necessary for every child who reaches 6 years by 31st August of the prospective year to enrol. The City of Nitra informs on its website about the places and dates of enrolment. The enrolment must be attended by child and his/her legal representative. If child comes to Slovakia during the school year, he/she must be enrolled in school immediately upon arrival in Slovakia.

You can contact directly the **Department of Education, Youth and Sports of the Municipal Office** with questions concerning the provision of primary education for the children of foreigners.

High School education



High Schools, High Vocational Schools and Vocational Schools fall within the competence of the Nitra self-governing region. Students can choose between general education, vocational specialized education with focus on certain subjects completed by high school diploma or vocational education which is completed without a high school diploma.

Universities and colleges in Nitra

In general, the studying conditions (accredited study program) at universities in Slovakia are the same for foreigners and Slovak nationals. The main conditions for admission to university studies are:

- ✔ completed required education,
- ✔ submission of an application.

The main condition for admission to university studies of the first degree, so-called bachelor's degree, is completed general high school education or completed high school vocational education (high school diploma or equivalent examination). The main condition for admission to university studies of the second degree - the master's program or engineer program is completed first degree university education or second degree university education. The main condition for admission to post gradual studies is a second degree university education. Universities may require foreigners to take preparatory courses (for example Slovak



language courses). Some universities organize separate Slovak language courses for its former students.

Tuition fee

Studying at state and public universities in a Slovak language programme is free of charge for Slovak nationals and for foreign students as well. According to the Higher Education Act, however, students must pay for studying in other language than Slovak. Price lists are published on the websites of the universities.

HOW TO PROCEED IF ... YOU WANT TO USE A PUBLIC TRANSPORT IN NITRA



Public transport in the city of Nitra is provided by ARRIVA buses. There are 28 public transport lines. [Timetables](#) can also be found directly at the bus stops. [Fares](#) can be paid directly to the driver, via SMS or chip card.

Parking system in Nitra



Nitra is divided into two parking zones, where it is possible to park only with a valid parking ticket. The parking ticket can be purchased at a vending machine or via SMS sent to 2200. The price of the parking fee in the 1st zone is 0.50 EUR for the first hour and 1.50 for each additional hour. The price of parking in the 2nd zone is 0.50 EUR for the first hour and 1 EUR for each additional hour.

If you want to travel **outside the city**, you can use a relatively rich train and bus network. There is a bus and train station in Nitra, which connects the city with nearby and more distant regions of Slovakia.
